- β) δεν πραγματοποιήθηκε κάποια δραστηριότητα αναφορικά με το σχέδιο αξιολόγησης.
- γ) δεν έχει αξιολογηθεί και ενταχθεί καμία πράξη στο Πρόγραμμα και ως εκ τούτου δεν έχει επιλεχθεί κανένας δικαιούχος.

Στο ανωτέρω πλαίσιο, τα μέλη της Επιτροπής Παρακολούθησης ενέκριναν στις 24 Ιουνίου 2016, την αποστολή μηδενικής έκθεσης για το έτος 2015.



Δεδομένου ότι το Επιχειρησιακό Πρόγραμμα εγκρίθηκε στα τέλη Οκτωβρίου του 2015, δεν ήταν δυνατή η ολοκλήρωση όλων των προβλεπόμενων ενεργειών. Παρόλα αυτά υλοποιήθηκαν τα ακόλουθα:

1. Η διαχειριστική αρχή (ΕΥΔ ΕΠΑΛΘ) προέβη στον καθορισμό του ρόλου της Επιτροπής Παρακολούθησης με την έκδοση σχετική απόφασης για τη συγκρότησή της (τον Ιανουάριο του 2016).
2. Η ΕΥΔ δεν προχώρησε στην δημιουργία της άτυπης ομάδας αξιολόγησης καθώς δεν είχε ακόμη εκδοθεί η Απόφαση για την ανασυγκρότηση της Υπηρεσίας βάσει του Νόμου 4314/2014.
3. Για την αναβάθμιση του πληροφοριακού συστήματος ΟΠΣΑΑ της Αρχής Πιστοποίησης, συγκροτήθηκε ομάδα εργασίας και ξεκίνησαν οι σχετικές εργασίες από τον ΟΠΕΚΕΠΕ ως αρμόδιο φορέα για την λειτουργία του.
4. Αναφορικά με τη συλλογή δεδομένων, προβλέπονται ρυθμίσεις για την έγκαιρη συλλογή και άθροιση των απαραίτητων στατιστικών δεδομένων μέσω ανάπτυξης ενός μηχανισμού στατιστικής επικύρωσης και συνεργασίας της ΕΥΔ με φορείς που μπορούν να παρέχουν σχετικά δεδομένα. Στο πλαίσιο αυτό ξεκίνησαν οι ενέργειες για την

δημιουργία δελτίων ταυτότητας των δεικτών του προγράμματος.

5. Η επικοινωνιακή στρατηγική ολοκληρώθηκε το έτος 2016.

6. Λόγω της καθυστερημένης έγκρισης του ΕΠΑΛΘ δεν εκτιμήθηκε η αναγκαιότητα χρήσης εξωτερικών αξιολογητών.
